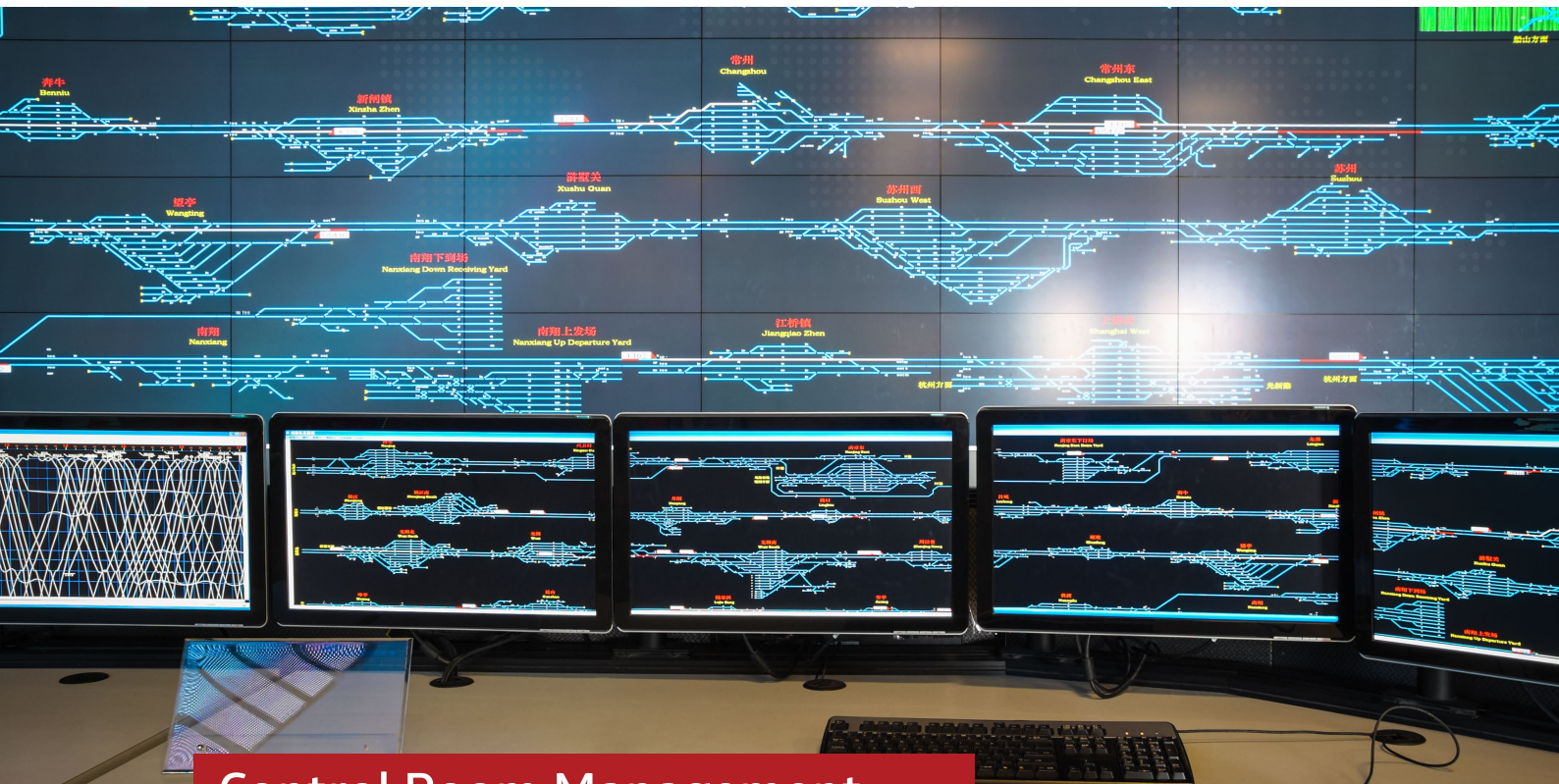
Protection Services

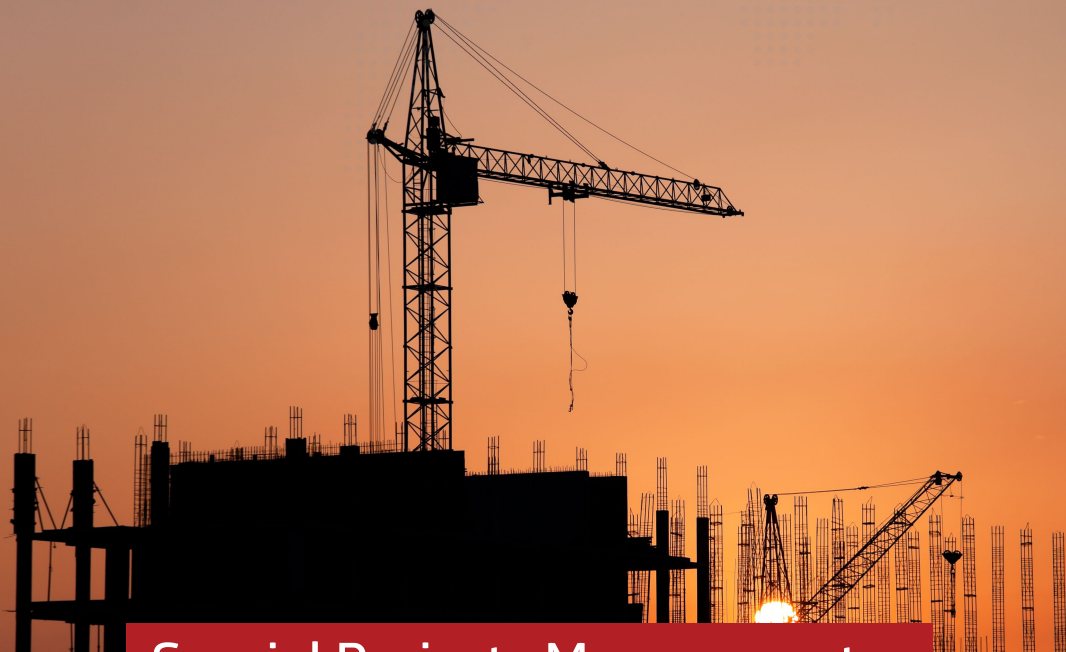


Control Room Management
